

# Solano Public Health Weekly COVID-19 Newsletter Issue 7

MAY 29, 2020

Solano County has moved to reopening additional business sectors, including places of worship, hair salons and barber shops. As the County continues to lift restrictions, the community is reminded to stay diligent in maintaining 6-foot physical distancing between others, washing hands frequently, practicing cough etiquette, and wearing cloth face coverings to curb the spread of coronavirus.

As of May 29, 2020, Solano County has 517 total confirmed cases reported, with 84 total hospitalizations, 69 active cases, 19 current hospitalizations, and 22 deaths. At present, The ICU and ventilator capacity are in the 'good' range.

We are continuing to actively respond to the COVID-19 situation, by investigating outbreaks, tracing contacts and monitoring the number of cases and hospital capacity, to protect the health of Solano County residents. We will follow State guidance on reopening additional sectors, and will move forward on reopening them in our County based on local conditions.

### **Gatherings outside of the immediate household are not permitted at this time**

To curb the spread of COVID-19, the Shelter-at-Home Health Order continues to be in place and **does not** allow for gatherings outside of the immediate household. Multi-household family and social gatherings are not permitted at this time. In order to prevent a surge in cases, community members need to stay diligent in maintaining 6-foot physical distance between others, washing hands frequently, sanitizing high-touch surfaces and wearing face coverings in public settings.

### Reopening Solano County Safely

#### **Hair salons, barber shops and places of worship can reopen with modifications**

Solano Public Health has amended the County's stay-at-home health order and directive, giving barbershops and hair salons permission to reopen if they meet [specific guidelines](#) as outlined by the state and [Appendix C-2](#) of the updated health order. Places of worship may also reopen if [state guidance](#) is followed, and the County's [social distancing protocol](#) is completed.

#### **Clarification on what activities can resume at hair salons and barbershops**

Certain activities can resume, including haircuts, hair colorings, blowouts, weaves, extensions, braiding, lock maintenance, wig maintenance and hair relaxing treatments - if both the customer and the employee wear face coverings throughout the service.

Certain salon activities **remain prohibited**, including shaving, facial waxing, threading, eyelash services, and facials in all Counties, as they require the employee to have direct contact with a customer's face.

#### **Golf courses may host tournament style events without spectators**

Tournament style events may be held as long as it does not involve the gathering of spectators. Tournament style events involving charitable activities or golf associations are allowed provided these events follow these guidelines and are held without spectators. Tournament score cards may be used but must be submitted in such a manner that limits contact with the cards themselves.

#### **People experiencing homelessness may be eligible for Project Roomkey**

Resources are limited, but unhoused individuals may be eligible for a motel room if they:

- Have tested positive for COVID-19 and do not require hospitalization OR have completed hospitalization but are still potentially infectious;
- Are under investigation for COVID-19 symptoms ;
- Are in a high-risk group, including: 60 or older AND/OR at high risk of medical complications from COVID-19 (preexisting lung disease, heart disease, cancer, diabetes, HIV or other major medical conditions).

### State-operated testing sites continue to be available in Vacaville and Vallejo

There are many appointment slots available for the state-operated testing sites in Vacaville and Vallejo. Community members with or without symptoms and want to get tested for COVID-19 can go to [lhi.care/covidtesting](https://lhi.care/covidtesting) to schedule an appointment. Those without internet access can call **888-634-1123**. Testing is free for those without health insurance, and for those that do, the health insurance plan will pay for the entire cost of the test. \*Testing site locations are subject to change\*
