<sup>\*</sup> Note: By motion of Commissioner Alvarez, seconded by Riddle, the recommended award for the Solano RCD application was increased by \$4,000, to a total of \$13,184, to support the environmental educators symposium proposed in the Solano RCD application. Motion was approved unanimously.

#### 6. Public Comments

Helayna Pera, California Department of Fish and Game, questioned why her applications were fully funded but others were not. The work they are doing on other properties in the Suisun Marsh is exactly the same work Fish and Game is doing, but they did not get funded. She stated that next year the Commission should focus more on the wildlife and habitat in the marsh.

Steve Chappell, Executive Director of Suisun RCD expressed disappointment that his applications were not being recommended for funding. He stated he invested a lot of personal time to create this grant program. He would like to see the process improve, and felt there was a systematic refusal of Suisun RCD's proposals. There are a lot of good things that can be done with this money. He stated the letters sent out from County Counsel should have stated what specifically was wrong with the applications, instead of having applicants come in and review their applications. He requested a copy of the applications that were being recommended for funding.

Hermsmeyer asked Staff Sykes whether the process was open to review again by the Park and Recreation Commission, or would the Board of Supervisors have to approve changes to the grant application process for future use. Could it be changed if needed?

Sykes said the application did not need to be approved by the Board, but any changes to the existing application and procedural guide should be reviewed by County Counsel.

Alvarez said he disagreed with the comments from Mr. Chappell. During his work in the park and recreation business for 38 years, he had never had a granting agency review applications and come back to the applicant to discuss what was wrong with an application. If the application was not complete the application was rejected. Alvarez state he thought the evaluation committee did an excellent job.

Riddle stated that he could not see a granting agency coaching someone through their application. He could see them having a workshop, which this process did, although only one person attended. Questions could have been brought and asked.

#### **SUMMARY:**

County Staff recommends that the Commission review the current application and procedural guide for the Fish and Wildlife Propagation Fund grant program for Fiscal Year 2008/09 and provide direction to the ad hoc Evaluation Committee and Staff to revise the procedural guide to make it appropriate for use with the Suisun Marsh-Specific Fund grant program, and distribute the procedural guide to the public.

#### **DISCUSSION:**

A procedural guide (Attachment 1) for the fiscal year 2008/09 Fish and Wildlife Propagation Fund Grant Program was approved by this Commission in July 2009. This procedural guide was used to receive applications for the grant program, which were recently awarded by the Board of Supervisors on January 6, 2009. The procedural guide has proved an effective tool in establishing guidelines and application procedures for the submission of grant applications, and Staff recommends that it be modified and used for the Suisun Marsh-Specific Fund grant program as well. With appropriate revisions, specifically to the evaluation criteria, funding goals and application process deadlines, the Suisun Marsh-Specific Fund Evaluation Committee would be able to modify the existing procedural guide to facilitate the Suisun Marsh-Specific Fund grant award process.

The Evaluation Committee is an ad hoc committee of the Commission that is appointed by the Chair of the Commission. A standing Evaluation Committee is already in place from the Fish and Wildlife Propagation Fund grant process. The Committee members are being solicited for their interest in continuing in this role, and may be able to be reappointed by the Chair at this meeting.

The procedural guide would need to be revised according to the directions for the disbursement of the "Suisun Marsh-Specific Fund" monies from the, "Guidelines for the Disbursement of Kinder Morgan Settlement Funds" (Kinder Morgan Guidelines) developed by the Commission in 2007 and adopted by the Board of Supervisors January 22, 2008. Pages 9-12 of the Kinder Morgan Guidelines that refer directly to the Suisun Marsh Specific Funds, are attached for your reference (Attachment 2).

In Fiscal Year 2008/09, the Board has budgeted \$100,000 from the Suisun Marsh-Specific Fund to be disbursed as competitive grants. Staff recommends that the Commission direct the Evaluation Committee to review the Kinder Morgan Guidelines and revise the procedural guide so that it can be used to facilitate this disbursement.

Staff has reviewed the procedural guide and identified in the *table of contents* those sections of the guide (see attached table of contents) that would need to be updated in accordance with the Kinder Morgan Guidelines.

Commissioners may also have other suggestions as to how the procedural guide or the application process should be modified, based on their assessment of the Fish and Wildlife Propagation Grant Program process for Fiscal Year 2008/09, which was just completed. Staff recommends that Commissioners also provide this direction to the Evaluation Committee at this meeting, for consideration in revising the procedural guide.

After the Evaluation Committee has met and revised the procedural guide, Staff anticipates it should be ready for reproduction and distribution to the public during February 2009.
