 - Developed a platform that is being used in the LA area helping clients link to services. This platform is HIPPA secure and algorithmically links clients to treatment. The client is imputed into the system and the platform sends referrals to those treatment facilities that meet the clients needs. There are no fees for patient advocates or MediCal facilities to use the platform.
- b. Carol Dunne- SLE proposal
 - Asking for Opioid settlement funds be applied to Vallejo homeless individuals through SLE funds.
 - Propose that these individuals be stabilized with MAT services, case management, and receive MH treatment.
 - This would help the county save in emergency service costs for these individuals.
