Housing Verification Steps

Before you can enter Customer Connect your resident will need a pin number generated by our office or the Call Center. This pin will allow them to log in and then they can change their password. Have resident call 866-901-3212 to request a pin if they need one. If the resident already has logged in before, but forgot their pin they can select forgot pin to request a new one.
