IMPORTANT NOTE FOR CITIES: Cities are responsible for the publication of the "Notice of Election" for their measures and the publication of the "Notice to Submit Arguments"; the receiving and processing of direct arguments/rebuttal arguments; the preparation of the Impartial Analyses and the 10-Day Public Examination Period. Due to this fact the cities' deadline for requesting consolidation with the election is the 88th day prior to Election Day. The last scheduled Board of Supervisors meeting prior to the 88th day is <u>August 9th</u>. The deadline for submitting the cities resolution requesting consolidation with the Clerk of the Board of Supervisors for the <u>August 9th</u> meeting is <u>July 26th</u>. The City must submit a calendar of events and deadlines to the Elections Office.
