1. Compliance Review No. 1 to Use Permit No. U-09-12 of **Jason Coleman** for a rural residential enterprise for Solano Archeological Services located at 6059 Clark Road, 6 miles south of the City of Dixon in an "A-40" Exclusive Agricultural Zoning District, APN: 0142-170-100. (Project Planner: Eric Wilberg)

PUBLIC HEARINGS

3. PUBLIC HEARING to consider Use Permit Application No. U-14-04 of Clarke Rosa for a 1,534 square foot seasonally occupied (private) clubhouse to support marsh oriented recreation at 2864 Grizzly Island Road, 5 miles south of the City of Suisun City in an "MP" Marsh Preservation Zoning District, APN: 0046-190-160. This consideration has been determined not to have a significant effect on the environment and is categorically exempt from the California Environmental Quality Act. (Project Planner: Eric Wilberg) Staff Recommendation: Approval

After a brief presentation of staff's written report, Mike Yankovich opened the public hearing. The applicant concurred with staff's recommendation for approval. PUBLIC HEARING to consider Minor Use Permit Application No. MU-15-01 of T-Mobile West, LLC for the co-location of antennas on an existing Crown Castle monopole located at Solano Community College at 4000 Suisun Valley Road, Fairfield, in an "A-SV20" Suisun Valley Agricultural Zoning District, APN: 0027-242-120. This consideration has been determined not to have a significant effect on the environment and is categorically exempt from the California Environmental Quality Act. (Project Planner: Karen Avery) This item is being reheard before the Zoning Administrator due to an increase in the number of antennas from 6 to 9. Staff Recommendation: Approval
