SHERIFF'S ENFORCEMENT TEAM (SET) CONDUCTS COMPLIANCE CHECKS

On Tuesday, July 28, 2015 the Solano County Sheriff's Enforcement Team (SET), assisted by Solano County Probation, conducted Post Community Release Supervision (PRCS) and Conditional Release (1170PC), compliance checks.

The team performed 18 checks, resulting in the arrest of 8 people. Those persons arrested are as follows:

1. Brian Butler, 55 years old of Vallejo was booked on possession and possession for sales of 2.68 grams of methamphetamine, 4.27 grams of cocaine, and six small individually packaged baggies of heroin and violation of PRCS.
2. Kenneth Brooks, 34 years old of Vallejo was booked on possession of narcotics paraphernalia and violation of PRCS.
3. Francisco Avina, 19 years old of Napa was arrested on a felony warrant issued by Napa County.
4. Vaalpulu Fuimaono, 44 years old of Vallejo booked on possession of methamphetamine and violation of probation.
5. Major Jordan, 27 years old of Vallejo was arrested on a felony warrant issued by Solano County.
6. Lamont Williams, 54 years old of Vallejo was arrested on a felony warrant issued by Solano County.
7. Clarence Jordan, 55 years old of Vallejo was arrested for violating his parole terms per the California Department of Corrections and Rehabilitation.

SET also seized one unsecured .22 caliber rifle along with a loaded magazine and loose ammunition during one of the searches.

The Solano County Sheriff's Enforcement Team (SET) continues to be a very important and productive part of the AB109 realignment within Solano County. The Team was formed to act as the enforcement arm for Solano County Probation regarding people arrested and sentenced under AB109. Solano County Probation oversees all inmates released from State Prison who are placed on Post Release Community Supervision (PRCS). Probation also oversees all people convicted of crimes considered Non-Serious, Non-Sexual, and Non-violent offenders under AB109. In addition, the Solano County Probation Department continues their traditional roll of overseeing subjects convicted of crimes and placed on probation within Solano County.
