VI. Long Term Financial Plan Update (10 min)

Consider adoption of the First 5 Solano 2008 Long Term Financial Plan Update, including an increase to the annual program investment level from \$4,120,000 to \$4,757,500 for the period FY2008/09 – FY2015/16, with associated administrative and evaluation costs of up to \$112,500 (adjusted for inflation) *Michele Harris, Deputy Director*

VII. Program Investment Plan Revision (10 min)

Action

Consider approval of the revised First 5 Solano 2007-2012 Program Investment Plan to incorporate increases in stable annual program investment levels in the Long Term Financial Plan

Increased funding for FY2007-2012 is as outlined in the Program Investment Plan, approximately: A.) increases in annual program investment levels across existing initiative areas as follows: Early Childhood Mental Health \$250,000; Children's Health Initiative \$40,000; Quality Child Care \$90,000; and Family Support Services \$102,000; and B) increase in Discretionary Fund average of \$187,000. Amounts are adjusted for inflation. Increased funding is phased in over FY2008/09, FY2009/10 and FY2010/11 *Michele Harris, Deputy Director*

 - Up to \$127,345 to The Children's Network of Solano County (\$41,200 for FY2009/10; \$42,636 for FY2010/11; \$43,709 for FY2011/12) to provide the First 5 California match portion of the program through the end of the 2007/2012 funding cycle. Authorize staff to work with The Children's Network of Solano to redesign the Quality Child Care grant funding as necessary to provide a more coordinated effort in Solano County. Source of funding: 2008 LTFP Update
 - Up to \$159,181 to Solano County Office of Education (\$51,500 for FY2009/10; \$53,045 for FY2010/11; \$54,636 for FY2011/12) to continue the Preschool For All Workgroup. Source of funding: 2008 LTFP Update
- D. Consider approval of the following awards for the Integrated Family Support Initiative:
 - 1. Up to \$120,978 to Fairfield-Suisun Unified School District (\$15,000 for FY2008/09; \$39,140 for FY2009/10; \$40,314 for FY2010/11; \$41,524 for FY2011/12) to incorporate the Family Resource Center at Cleo Gordon into the Initiative. Source of funding: 2008 LTFP Update
 - Up to \$99,458 to Benicia Police Department (\$13,500 for FY2008/09; \$27,810 for FY2009/10; \$28,644 for FY2010/11; \$29,504 for FY2011/12) to increase the current 0.5 FTE Site Coordinator to 1.0 FTE. Source of funding: 2008 LTFP Update
 - Up to \$99,458 to Fighting Back Partnership (\$13,500 for FY2008/09; \$27,810 for FY2009/10; \$28,644 for FY2010/11; \$29,504 for FY2011/12) to add 1.0 FTE for an Information and Referral Specialist. Source of funding: 2008 LTFP Update
 - 4. Up to \$36,836 to Interfaith Council of Solano County (\$5,000 for FY2008/09; \$10,300 for FY2009/10; \$10,609 for FY2010/11; \$10,927 for FY2011/12) to increase the current 0.03 FTE Shelter Attendant to 0.5 FTE. Source of funding: 2008 LTFP Update
