#### ELECTION CALENDAR DEADLINE CHANGE:

The Solano County Registrar of Voters Office is modifying the deadlines related to Measures. These dates include filing deadlines for Impartial Analysis, Arguments and Rebuttals. This will also modify the public viewing period as shown. This change is being implemented due to the alignment of schedules to adhere to the multi-jurisdictional deadlines related to Measure AA by the Bay Area Restoration Authority. Anyone who has previously submitted an argument, or rebuttal may make changes to their documents until the new deadline date.
