



2018 Statewide Direct Primary Notice of Election

NOTICE is hereby given to all qualified persons that a Statewide Primary Election will be held in the County of Solano, State of California, on June 5, 2018 for the following offices:

Voter Nominated Offices:

- United States Senate; Representative in Congress - Districts 3 and 5;
- Member of the State Assembly - Districts 4, 11 and 14;
- State Elected Offices: Governor, Lt. Governor, Secretary of State, Controller, Treasurer, Attorney General, Insurance Commissioner, State Superintendent of Public Instruction, Board of Equalization;

Nonpartisan County Offices:

- Solano County Supervisors - Districts 3 and 4;
- Superior Court Judges - Departments 3, 5, 6, 9, 11 and 15;
- County Elected Offices - Assessor/Recorder, Auditor-Controller, District Attorney, Sheriff/Coroner, Superintendent of Schools, Treasurer/Tax Collector/County Clerk.

All qualified persons who wish to become a candidate may file nomination papers with the Registrar of Voters Office located at 675 Texas Street, Suite 2600, in Fairfield, CA. The date you may file nomination papers begins February 13, 2018 and ends March 9, 2018 at 5:00 P.M. If the person who currently holds an office (the incumbent) does not file papers by 5:00 P.M. on March 9, 2018, the filing period is extended until 5:00 P.M. on March 14, 2018 to allow any person other than the incumbent to file papers.

NOTICE is further given that an appointment for an office will be made in the event no candidate has filed or insufficient candidates have filed and a petition for an election is not filed within the time prescribed by law.

NOTICE is further given that in accordance with provisions of the Streets and Highways Code and the California Elections Code, an election to consider implementing the Bay Area traffic Relief Plan by raising bridge tolls on the bay Area's seven state-owned toll bridges (Antioch Bridge, the Benicia-Martinez Bridge, the Carquinez Bridge, the Dumbarton Bridge, the Richmond-San Rafael Bridge, the San Francisco-Oakland Bay

Bridge and the San Mateo-Hayward Bridge) will be consolidated with the Tuesday, June 5, 2018 Statewide Direct Primary Election for the Measure shown below.

Regional Measure 3 (RM3):

- Regional Measure 3 - Bay Area Traffic Relief Plan

Shall voters authorize a plan to reduce auto and truck traffic, relieve crowding on BART, unclog freeway bottlenecks, and improve bus, ferry, BART and commuter rail service as specified in the plan in this voter pamphlet, with a \$1 toll increase effective in 2019, a \$1 increase in 2022, and a \$1 increase in 2025, on all Bay Area toll bridges except the Golden Gate Bridge, with independent oversight of all funds?

NOTICE is further given that the Governing Body of the Authority, or any members thereof authorized by such body, or any individual voter, or bona fide association of citizens, or any combination of such voters and associations, may file a written argument for or against said measure, not to exceed 300 words in length. If arguments are submitted both for and against Regional Measure 3, the authors may prepare and submit rebuttal arguments not to exceed 250 words.

NOTICE is further given that March 16th is the last day to file arguments for or against Regional Measure 3. Arguments for or against the measure shall be filed in the Registrar of Voters Office, 675 Texas Street, Suite 2600, Fairfield, CA., no later than 5:00 P.M.

March 20th is the last day to file rebuttal arguments for or against Regional Measure 3. Rebuttals are not to exceed 250 words in length. Rebuttals shall be filed with the Registrar of Voters, no later than 5:00 P.M.

In accordance with section 9600 of the California Elections Code, all arguments and rebuttals filed pursuant to this notice shall be accompanied by a signature statement form to be signed by each author.
