Re: City of Vacaville District 2 Vacancy Election

The Solano County Registrar of Voters issued public notice for random draw of the 1 Percent Manual Tally per EC 15360 with the random selection to commence Thursday, May 6th at 10:00 a.m. No observers from the public attended. The audit was conducted on Thursday May 6th until all precincts and batches were completed.

This was an all Vote by Mail Election. Solano county utilized batches of up to 200 ballots to count ballots. Six batches were initially randomly drawn, and eight additional batches were added to ensure all precincts and a minimum 1% of all ballots cast were audited. There was only one contest in this election. Batches of ballots were all in the same supervisorial district. The manual tally confirmed the machine counts for vote by mail ballots as follows:

Overall, 6 of 6 precincts (100%), 14 of 62 vote by mail batches (22.5%), representing 862 of 3,259 vote by mail ballots cast (26.4%) were manually audited. In each case, the hand count of ballots matched the machine count produced on election night.
