

VOTING OPTIONS FOR ALL VOTERS



In an effort to provide a safe voting environment, the Solano County Registrar of Voters has prepared several voting options for all voters. You have received a Vote by Mail ballot for the election in this packet.

Below is a description of the different options you have for voting to help provide a safe voting environment for all voters, our staff, and our community partners:

No Contact Voting:

As an option to in-person voting, all voters can vote from the safety of your home, using the enclosed ballot. Ballots can be returned to our office in one of three manners:



Ballot Drop-Off:

Starting 29-days before the election through Election Day - Drop-off times and locations are identified on the next page (drop box is inside an office building).



Curbside Drop-Off:

Starting 5-days before the election through Election Day - Curbside drop-off times and locations are identified on the next page (stay in your vehicle, hand ballot to poll workers).



Election Day Drop-Off:

Election Day (1-day) - Poll Place drop-off locations are available on Election Day- all locations are open 7a.m. to 8p.m.

All ballots must be received or post-marked by Election Day. All postage is paid by the Registrar of Voters Office for voters mailing ballots back to our office. Voters do not have to vote this ballot, and can still choose to vote in-person using one of the options listed below.

Limited Contact Voting:



At your assigned poll place, all voters can request to vote "curbside" from the comfort of your vehicle. Look for the blue cone outside of your polling place, and call the number listed on the cone. Poll workers will come out to your vehicle with your ballot and will securely deposit it for you.

This same curbside option is available if you want to drop off your Vote by Mail ballot. It may be preferable for you to remain in your vehicle and we support that option.

In-Person Voting:



Traditional polling places are still available. Your assigned location is included on the cover sheet with your official ballot. Some voters may experience additional wait times due to the need to provide social distancing within the voting location. Please be prepared: it may take longer than usual to vote at your polling place.

COVID-19 INFO:

Poll Workers and Staff:

All poll workers will be provided masks and shields, additionally the Registrar of Voters will provide gloves, hand sanitizer, and disinfecting wipes.

Voters:

Face coverings will be provided to any voter requesting/needing one. Hand sanitizer and disposable pens will be provided to all voters. Voters without face coverings may vote from the safety of their vehicles as described above.

The Registrar of Voters encourages all citizens to follow the mandated health requirements to help protect our staff and community partners. Without our staff and volunteers we cannot successfully execute an election! Please help us minimize the risk to those helping to administer your voting rights!



WHAT OFFICES ARE ON THE BALLOT FOR THIS ELECTION?

In the November Statewide General Election, all voters receive the same ballot, no matter what political party you are registered with (or if you have no party preference). The address where you are registered to vote determines which local contests are on your ballot.

In the June Primary Election, all Californians were able to vote to decide which candidates for federal and state offices moved on to the November General Election. You will see two differents types of primaries: **Nominated by Voters**, and **Local Nonpartisan**.

STATEMENT OF CANDIDATE FOR UNITED STATES REPRESENTATIVE IN CONGRESS, DISTRICT 8

JOHN GARAMENDI

Occupation: Member of Congress

Education and Qualifications: I get things done for Solano County. As your Congressman, I fight for good jobs, good schools, good healthcare, and a good future.

The economy can't move if people can't move. I helped design and pass the Bipartisan Infrastructure Law to create jobs in Solano County. We'll upgrade I-80, rebuild highway 37, improve public transportation and water supply, and build green energy systems with American materials and workers.

As Chair of the Armed Services Readiness Subcommittee, I've secured \$440 million to upgrade Travis Air Force Base, guaranteeing the future of the base and its jobs.

I'll never forget our Veterans. In Congress, we've tripled funding for vets and passed the toxic burn pits act. We're building new VA medical facilities and expanding veteran healthcare services.

Impartial Analysis of Measure E

SOLANO COUNTY - TRANSACTION AND USE TAX ORDINANCE

The County of Solano has proposed a general transactions and use tax (sales tax) of one-eighth of one cent per dollar (0.125%).

State law authorizes the County to levy a general sales tax if the ordinance proposing the tax is approved by a two-thirds vote of all members of the Board of Supervisors and the tax is approved by a majority of the qualified voters of the entire county voting in the election. On August 9, 2022 the Solano County Board of Supervisors adopted the ordinance and approved submitting it to the voters with four Supervisors voting in favor and one Supervisor voting against. If a majority of the voters in the County who vote on this measure vote "Yes," the measure will pass and the sales tax will be levied.

The proposed tax is a general sales tax that is estimated to raise \$9,000,000.00 annually. All revenue generated from the tax would be deposited into the County's General Fund and would be available for general governmental purposes. This measure does not restrict the use of the tax revenue to any specific purpose.

The tax would be paid in addition to the current sales tax. Like the current sales tax, the proposed tax would be imposed on all retailers in the incorporated and unincorporated territory of the County for the selling of tangible personal property, subject to certain exemptions and exclusions identified in the measure.

If approved, the tax would take effect immediately on November 8, 2022 and become operative on April 1, 2023. The tax would be levied for an indefinite term and could be terminated by a majority of the voters of the County of Solano by means of a ballot measure to repeal the tax at a future general or special election.

Measure ${\bf E}$ requires approval by simple majority of the voters of the County voting on it.

A "Yes" vote is a vote to authorize the County to levy a general sales tax of one-eighth of one cent per dollar (0.125%) on purchases throughout the County with certain exemptions and exclusions.

A "No" vote is a vote to not authorize the County to levy the proposed tax.

ORDINANCE NO 2022-1834

AN ORDINANCE OF THE COUNTY OF SOLANO IMPOSING A TRANSACTION AND USE TAX TO BE ADMINISTERED BY THE CALIFORNIA DEPARTMENT OF TAX AND FEE ADMINISTRATION

THE SOLANO COUNTY BOARD OF SUPERVISORS ORDAINS AS FOLLOWS:

Section I. Chapter 11 of the Solano County Code is amended to add Article XVII and Sections 11-700 through 11-714, to read as follows:

ARTICLE XVII. SOLANO COUNTY TRANSACTION AND USE TAX

Sec. 11-700 Title. This ordinance shall be known as the Solano County Transaction and Use Tax Ordinance. This ordinance shall be applicable in the incorporated and unincorporated territory of Solano County ("County").

Sec. 11-701 General Tax. The tax imposed by this chapter is a general tax under Article XIIIC of the California Constitution. The tax imposed by this chapter enacted solely for general governmental purposes

Sec. 11-702 Purpose. This ordinance is adopted to achieve the following purposes:

- (a) To impose a retail transactions and use tax in accordance with the provisions of Part 1.6 (commencing with Section 7251) of Division 2 of the Revenue and Taxation Code and Section 7285 of Part 1.7 of Division 2 which authorizes the County to adopt this tax ordinance which shall be operative if a majority of the electors voting on the measure vote to approve the imposition of the tax at an election called for that purpose.
- (b) To adopt a retail transactions and use tax ordinance that incorporates provisions identical to those of the Transactions (Sales) and Use Tax Law of the State of California insofar as those provisions are not inconsistent with the requirements and limitations contained in Part 1.6 of Division 2 of the Revenue and Taxation Code.
- (c) To adopt a retail transactions and use tax ordinance that imposes a tax and provides a measure therefore that can be administered and collected by the California Department of Tax and Fee Administration in a manner that adapts itself as fully as practicable to, and requires the least possible deviation from, the existing statutory and administrative procedures followed by the California Department of Tax and Fee Administration in administering and collecting the California State Transactions (Sales) and Use Taxes.
- (d) To adopt a retail transactions and use tax ordinance that can be administered in a manner that will be, to the greatest degree possible, consistent with the provisions of Part 1.6 of Division 2 of the Revenue and Taxation Code, minimize the cost of collecting the transactions and use taxes, and at the same time, minimize the burden of record keeping upon persons subject to taxation under the provisions of this ordinance.

Sec. 11-703 Transaction Tax Rate. For the privilege of selling tangible personal property at retail, a tax is hereby imposed upon all retailers in the incorporated and unincorporated territory of the County at the rate of one eighth of one per cent (0.125%) of the gross receipts of any retailer from the sale of all tangible personal property sold at retail in said territory on and after the operative date of this ordinance.

Sec. 11-704 Place of Sale. For the purposes of this ordinance, all retail sales are consummated at the place of business of the retailer unless the tangible personal property sold is delivered by the retailer or his agent to an out-of-state destination or to a common carrier for delivery to an out-of-state destination. The gross receipts from such sales shall include delivery charges, when such charges are subject to the state sales and use tax, regardless of the place to which delivery is made. In the event a retailer has no permanent place of business in the State or has more than one place of business, the place or places at which the retail sales are consummated shall be determined under rules and regulations to be prescribed and adopted by the California Department of Tax and Fee Administration.

Sec. 11-705 Use Tax Rate. An excise tax is hereby imposed on the storage, use or other consumption in the County of tangible personal property purchased from any retailer on and after the operative date of this ordinance for storage, use or other consumption in said territory at the rate of one eighth of one per cent (0.125%) of the sales price of the property. The sales price shall include delivery charges when such charges are subject to state transactions (sales) or use tax regardless of the place to which delivery is made.

Sec. 11-706 Adoption of Provisions of State Law. Except as otherwise provided in this ordinance and except insofar as they are inconsistent with the provisions of Part 1.6 of Division 2 of the Revenue and Taxation Code, all of the provisions of Part 1 (commencing with Section 6001) of Division 2 of the Revenue and Taxation Code are hereby adopted and made a part of this ordinance as though fully set forth herein.

Sec. 11-707 Limitations on Adoption of State Law and Collection of Use Taxes.

In adopting the provisions of Part 1 of Division 2 of the Revenue and Taxation Code:

- (a) Wherever the State of California is named or referred to as the taxing agency, the name of this County shall be substituted therefor. However, the substitution shall not be made when:
 - (1) The word "State" is used as a part of the title of the State Controller, State Treasurer, State Treasury, or the Constitution of the State of California.
 - (2) The result of that substitution would require action to be taken by or against this County or any agency, officer, or employee thereof rather than by or against the California Department of Tax and Fee Administration, in performing the functions incident to the administration or operation of this Ordinance.
 - (3) In those sections, including, but not necessarily limited to sections referring to the exterior boundaries of the State of California, where the result of the substitution would be to:
 - (A) Provide an exemption from this tax with respect to certain sales, storage, use or other consumption of tangible personal property which would not otherwise be exempt from this tax while such sales, storage, use or other consumption remain subject to tax by the State under the provisions of Part 1 of Division 2 of the Revenue and Taxation Code, or;
 - (B) Impose this tax with respect to certain sales, storage, use or other consumption of tangible personal property which would not be subject to tax by the state under the said provision of that code.
 - (4) In Sections 6701, 6702 (except in the last sentence thereof), 6711, 6715, 6737, 6797 or 6828 of the Revenue and Taxation Code.
- (b) The word "County" shall be substituted for the word "State" in the phrase "retailer engaged in business in this State" in Section 6203 and in the definition of that phrase in Section 6203.
 - (1) "A retailer engaged in business in the County" shall also include any retailer that, in the preceding calendar year or the current calendar year, has total combined sales of tangible personal property in this state or for delivery in the State by the retailer and all persons related to the retailer that exceeds five hundred thousand dollars (\$500,000). For purposes of this section, a person is related to another person if both persons are related to each other pursuant to Section 267(b) of Title 26 of the United States Code and the regulations thereunder.

Sec. 11-708 Permit Not Required. If a seller's permit has been issued to a retailer under Section 6067 of the Revenue and Taxation Code, an additional transactor's permit shall not be required by this ordinance.

Sec. 11-709 Exemptions and Exclusions.

- (a) There shall be excluded from the measure of the transactions tax and the use tax the amount of any sales tax or use tax imposed by the State of California or by any city, city and county, or county pursuant to the Bradley-Bums Uniform Local Sales and Use Tax Law or the amount of any state-administered transactions or use tax.
- (b) There are exempted from the computation of the amount of transactions tax the gross receipts from:
 - (1) Sales of tangible personal property, other than fuel or petroleum products, to operators of aircraft to be used or consumed principally outside the County in which the sale is made and directly and exclusively in the use of such aircraft as common carriers of persons or property under the authority of the laws of this State, the United States, or any foreign government.
 - (2) Sales of property to be used outside the County which is shipped to a point outside the County, pursuant to the contract of sale, by delivery to such point by the retailer or his agent, or by delivery by the retailer to a carrier for shipment to a consignee at such point. For the purposes of this paragraph, delivery to a point outside the County shall be satisfied:
 - (A) With respect to vehicles (other than commercial vehicles) subject to registration pursuant to Chapter 1 (commencing with Section 4000) of Division 3 of the Vehicle Code, aircraft licensed in compliance with Section 21411 of the Public Utilities Code, and undocumented vessels registered under Division 3.5 (commencing with Section 9840) of the Vehicle Code by registration to an out-of-County address and by a declaration under penalty of perjury, signed by the buyer, stating that such address is, in fact, his or her principal place of residence; and
 - (B) With respect to commercial vehicles, by registration to a place of business out-of-County and declaration under penalty of perjury, signed by the buyer, that the vehicle will be operated from that address.
 - (3) The sale of tangible personal property if the seller is obligated to furnish the property for a fixed price pursuant to a contract entered into prior to the operative date of this ordinance.
 - (4) A lease of tangible personal property which is a continuing sale of such property, for any period of time for which the lessor is obligated to lease the property for an amount fixed by the lease prior to the operative date of this ordinance.
 - (5) For the purposes of subparagraphs (3) and (4) of this section, the sale or lease of tangible personal property shall be deemed not to be obligated pursuant to a contract or lease for any period of time for which any party to the contract or lease has the unconditional right to terminate the contract or lease upon notice, whether or not such right is exercised.
- (c) There are exempted from the use tax imposed by this ordinance, the storage, use or other consumption in this County of tangible personal property:
 - (1) The gross receipts from the sale of which have been subject to a transactions tax under any state-administered transactions and use tax ordinance.

- (2) Other than fuel or petroleum products purchased by operators of aircraft and used or consumed by such operators directly and exclusively in the use of such aircraft as common carriers of persons or property for hire or compensation under a certificate of public convenience and necessity issued pursuant to the laws of this State, the United States, or any foreign government. This exemption is in addition to the exemptions provided in Sections 6366 and 6366.1 of the Revenue and Taxation Code of the State of California.
- (3) If the purchaser is obligated to purchase the property for a fixed price pursuant to a contract entered into prior to the operative date of this ordinance.
- (4) If the possession of, or the exercise of any right or power over, the tangible personal property arises under a lease which is a continuing purchase of such property for any period of time for which the lessee is obligated to lease the property for an amount fixed by a lease prior to the operative date of this ordinance.
- (5) For the purposes of subparagraphs (3) and (4) of this section, storage, use, or other consumption, or possession of, or exercise of any right or power over, tangible personal property shall be deemed not to be obligated pursuant to a contract or lease for any period of time for which any party to the contract or lease has the unconditional right to terminate the contract or lease upon notice, whether or not such right is exercised.
- (6) Except as provided in subparagraph (7), a retailer engaged in business in the County shall not be required to collect use tax from the purchaser of tangible personal property, unless the retailer ships or delivers the property into the County or participates within the County in making the sale of the property, including, but not limited to, soliciting or receiving the order, either directly or indirectly, at a place of business of the retailer in the County or through any representative, agent, canvasser, solicitor, subsidiary, or person in the County under the authority of the retailer.
- (7) "A retailer engaged in business in the County" shall also include any retailer of any of the following: vehicles subject to registration pursuant to Chapter 1 (commencing with Section 4000) of Division 3 of the Vehicle Code, aircraft licensed in compliance with Section 21411 of the Public Utilities Code, or undocumented vessels registered under Division 3 .5 (commencing with Section 9840) of the Vehicle Code. That retailer shall be required to collect use tax from any purchaser who registers or licenses the vehicle, vessel, or aircraft at an address in the County.
- (d) Any person subject to use tax under this ordinance may credit against that tax any transactions tax or reimbursement for transactions tax paid to a County imposing, or retailer liable for a transactions tax pursuant to Part 1.6 of Division 2 of the Revenue and Taxation Code with respect to the sale to the person of the property the storage, use or other consumption of which is subject to the use tax.
- **Sec. 11-710 Amendments.** All amendments subsequent to the effective date of this ordinance to Part 1 of Division 2 of the Revenue and Taxation Code relating to sales and use taxes and which are not inconsistent with Part 1.6 and Part 1.7 of Division 2 of the Revenue and Taxation Code, and all amendments to Part 1.6 and Part 1.7 of Division 2 of the Revenue and Taxation Code, shall automatically become a part of this ordinance, provided however, that no such amendment shall operate so as to affect the rate of tax imposed by this ordinance.
- **Sec. 11-711 Enjoining Collection Forbidden.** No injunction or writ of mandate or other legal or equitable process shall issue in any suit, action or proceeding in any court against the State or the County, or against any officer of the State or the County, to prevent or enjoin the collection under this ordinance, or Part 1.6 of Division 2 of the Revenue and Taxation Code, of any tax or any amount of tax required to be collected.
- **Sec. 11-712 Operative Date.** "Operative Date" means the first day of the first calendar quarter commencing more than 110 days after the adoption of this ordinance by the voters, the date of such adoption being as set forth below.
- **Sec. 11-713 Termination Date.** The transactions and use tax imposed by this article shall have an indefinite term. The foregoing notwithstanding, the transaction and use tax established by this article may be terminated by a majority of the voters of the County of Solano by means of a ballot measure to repeal the same at a future general or special election of the county.
- **Sec. 11-714 Severability.** If any provision of this ordinance or the application thereof to any person or circumstance is held invalid, the remainder of the ordinance and the application of such provision to other persons or circumstances shall not be affected thereby.

SECTION III Effective Date.

(A) The Board of Supervisors adopted this ordinance on August 9, 2022 and approved submitting this ordinance to the voters at an election to be held on November 8, 2022. Within 15 days after passage by the Board of Supervisors, this ordinance shall be published in a manner satisfying the requirements of Government Code section 25124, with the names of supervisors voting for and against it. If adopted by a majority of the voters voting on the ordinance at an election on November 8, 2022, this ordinance shall take effect immediately, pursuant to Elections Code section 9141.

SECTION IV Contract with State. Prior to the operative date, the County shall contract with the California Department of Tax and Fee Administration to perform all functions incident to the administration and operation of this transactions and use tax ordinance; provided, that if the County shall not have contracted with the California Department of Tax and Fee Administration prior to the operative date, it shall

nevertheless so contract and in such a case the operative date shall be the first day of the first calendar quarter following the execution of such a contract.
SECTION V. Adjustment of Appropriations Limit. Pursuant to Article XIIIB of the Constitution of the State of California and applicable laws, the appropriations limit for the County is hereby increased by the aggregate sum authorized to be levied by this tax for fiscal year 2022-23 and each fiscal year thereafter.

ARGUMENT IN FAVOR OF MEASURE E

With an ever-present and growing risk of wildfire that threatens our residential and rural communities, Measure E will provide enhanced wildfire prevention and protection to all of Solano County's residents.

The effect of prolonged drought conditions and extreme weather has increased the occurrence of wildfire in Solano County. The fuel load is high, with dead trees and tinder dry conditions providing the perfect ingredients for a disastrous wildfire to start in our open space and bear down on our cities. This is what happened during the 2020 LNU Lightning Complex Fire that killed two Solano County residents, leveled 309 homes, destroyed thousands of livestock and family pets and forced the evacuations of Travis Air Force Base and portions of Fairfield and Vacaville.

A 2022 Solano County Civil Grand Jury report stated: "Solano County Is Not Prepared for Future Emergencies."

It is time to dedicate additional money and resources to address the challenges we face in Solano County. Wildfire does not respect county lines or city boundaries and revenues dedicated to wildfire prevention are shrinking.

Measure E will provide an estimated \$9,000,000 annually to support fire prevention and protection efforts across Solano County. It will provide additional fire response, including equipment and support programs, to improve 9-1-1 response times, thereby saving life and property.

Measure E will reduce the risk of wildfires threatening residential neighborhoods from rural areas by providing enhanced fire protection services to prevent the spread of fires into cities. Revenues will be used to create and maintain rural and city firebreaks and reduce dead trees and weeds in public open spaces.

We strongly urge you to vote YES on Measure E.

IMPARTIAL ANALYSIS OF MEASURE M TRAVIS UNIFIED SCHOOL DISTRICT – SCHOOL BOND MEASURE

Measure **M** would authorize the sale of general obligation bonds of the Travis Unified School District ("District") in series in the aggregate amount of up to \$64,000,000. Measure **M** will not amend any existing laws. The District's governing board ("Board") placed Measure **M** on the ballot.

The California Constitution limits the use of proceeds from such bonds to construction, reconstruction, rehabilitation, or replacement of school facilities, including the furnishing and equipping of school facilities, or the acquisition or lease of real property for school facilities. If approved by the voters of the District, bond proceeds could only be used for those activities identified in the Bond Project List (reprinted completely in the sample ballot pamphlet). Bond funds could not be used for teacher or administrator salaries or other school operating expenses.

The District cannot guarantee that the bonds will provide sufficient funds to allow completion of all the Bond Projects. Certain projects may require State matching funds for their completion.

Independent performance and financial audits must be conducted annually. By law, the District is required to have an independent citizens' oversight committee to help ensure that bond funds are spent only for projects included in the Bond Project List.

If Measure **M** is approved, the District may issue bonds either under the Government or Education Code. Bonds issued under the Government Code must mature within 40 years and may not have interest rates that exceed 12%. Bonds issued under the Education Code must mature within 25 years and may not have interest rates that exceed 8%.

The bonds would be repaid through a property tax levied and collected by the County each year on all taxable property within the District in an amount sufficient to pay the interest and principal coming due prior to the next year's tax levy. The District's stated best estimate of the average annual tax rate that would need to

be levied to fund the proposed bonds is \$60 per \$100,000 of assessed value of taxable property within the District. The District's stated best estimate of the highest tax rate that would need to be levied to repay the proposed bonds is \$60 per \$100,000 of assessed value of taxable property within the District. The District estimates that the total debt service during the life of the bonds, including principal and interest, would be \$124,000,000.

The procedures required for the approval and issuance of the general obligation bonds, including the process of submitting Measure \mathbf{M} to the vote of the District's electors, were satisfied.

Measure \mathbf{M} requires approval by 55 percent of the voters of the district voting on it.

A "Yes" vote is a vote to authorize the issuance of bonds totaling up to \$64,000,000 to fund specified school facilities projects secured by the levy of ad valorem taxes on property located within the District.

A "No" vote is a vote to not authorize the issuance of the bonds.

RESOLUTION #2022-23-01

RESOLUTION OF THE GOVERNING BOARD OF THE TRAVIS UNIFIED SCHOOL DISTRICT ORDERING A SCHOOL BOND ELECTION ON NOVEMBER 8, 2022 AND AUTHORIZING NECESSARY ACTIONS IN CONNECTION THEREWITH

WHEREAS, the Governing Board ("Board") of the Travis Unified School District ("District"), in Solano County, California is authorized to order elections within the District and to designate the specifications thereof, pursuant to Sections 5304 and 5322 of the California Education Code ("Education Code");

WHEREAS, the Board believes that a high quality education is the fundamental right of every student, and seeks to provide a 21st century education in a safe and engaging learning environment for all students;

WHEREAS, many District schools and buildings are over 50 years old, and many schools are in need of upgrades, repairs and improvements to meet modern standards;

WHEREAS, the District must repair, construct, acquire or equip classrooms, sites, and facilities to make them safer and help ensure that all students have equal access to 21st century classrooms, labs and school facilities;

WHEREAS, classrooms and educational facilities require updates for improved student learning in subjects like reading, math, science, engineering, arts and technology;

WHEREAS, the Board believes it is a wise investment to protect the quality of our schools, the quality of life in our community and the value of our homes:

WHEREAS, the Board and District has solicited input on school priorities from parents, teachers, staff, and the community through surveys and public opinion research;

WHEREAS, bonds are the primary means by which local school districts are able to keep school buildings and classrooms in good repair, safe, designed and equipped to support changing educational standards, methods and approaches; and

WHEREAS, the District cannot rely on the State of California to fully fund school facility improvements since limited state dollars available for facility upgrades often require local matching funds that could be provided by a local bond measure; and

WHEREAS, the District is proposing this bond measure to fund improvements to classrooms, science labs and other educational facilities to support quality academic instruction for students; and

WHEREAS, this bond measure will benefit local schools only and no funds can be taken away by the State or other school districts, and by law, no money can be used for operating expenses, including administrator salaries or pensions; and

WHEREAS, this bond measure requires strict fiscal accountability protections including mandatory annual audits and an independent citizens' oversight committee comprised of local residents to ensure funds are managed and spent properly; and

WHEREAS, the Board is specifically authorized to order elections for the purpose of submitting to the electors the question of whether bonds of the District shall be issued and sold for the purpose of raising money for the purposes hereinafter specified, pursuant to Section 15100 *et seg.* of the Education Code; and

WHEREAS, pursuant to section 18 of Article XVI and section 1 of Article XIII A of the California Constitution (also known as "Proposition 39"), and Section 15266 of the Education Code, school districts may seek approval of general obligation bonds and levy an *ad valorem* tax to repay those bonds upon a fifty-five percent (55%) vote of those voting on a proposition for that purpose, provided certain accountability measures are included in the proposition; and

WHEREAS, the Board deems it necessary and advisable to submit such a bond proposition to the electors to be approved by fifty-five percent (55%) of the votes cast; and

WHEREAS, such a bond election must be conducted concurrent with a statewide primary election, general election or special election, or at a regularly scheduled local election, as required by Section 15266 of the Education Code, and on November 8, 2022, a general election is scheduled to occur throughout the District; and

WHEREAS, pursuant to Section 15270 of the Education Code, if the measure is approved by the voters, bonds may only be issued if the tax rate levied to meet the debt service requirements would not exceed sixty dollars (\$60) per year per one hundred thousand dollars (\$100,000) of taxable property when assessed valuation is projected by the District to increase in accordance with Article XIIIA of the California Constitution, and the current estimated and projected average annual tax rate and highest tax rate, is not expected to exceed a tax rate levy of \$60 per year per each \$100,000 of the assessed value of taxable property; and

WHEREAS, the estimated tax rates, duration of tax collection, and total estimated amount of debt service, is described in the Tax Rate Statement contained in **Exhibit C** hereto; and

WHEREAS, Section 9400 *et seq.* of the California Elections Code requires that a tax rate statement be contained in all official materials, including any ballot pamphlet prepared, sponsored or distributed by the District, relating to the election; and

WHEREAS, in the judgment of the Board, it is advisable to request that the Solano County Registrar of Voters ("County Registrar") act as the election official and call an election and submit to the registered voters of the District the full ballot proposition as detailed herein, in coordination with each other as necessary; and

WHEREAS, the Board now desires to authorize the filing of a ballot argument in favor of the proposition to be submitted to the voters at the election.

NOW, THEREFORE, be it resolved, determined and ordered by the Governing Board of Travis Unified School District as follows:

Section 1. Specifications of Election Order. Pursuant to Sections 5304, 5322, 15100 et seq., and Section 15266 of the Education Code, an election shall be held within the District on November 8, 2022, for the purpose of submitting to the registered voters of the District the full ballot proposition contained in **Exhibit B** ("Full Ballot Text"), which Full Ballot Text is hereby approved. The County Registrar shall provide for the performance of its duties in accordance with Education Code section 5303 and in accordance with any and all other laws and regulations applicable to such elections.

Section 2. Abbreviation of Proposition/Ballot Label. Pursuant to Sections 13119 and 13247 of the California Elections Code and Section 15122 of the Education Code, the Board hereby directs the County Registrar to use the abbreviation of the Full Ballot Text ("Ballot Label") that is attached hereto as **Exhibit A**. The Ballot Label shall function merely as an abbreviation of the Full Ballot Text and does not stand alone as a complete and binding statement of the measure, nor is it possible for the Ballot Label to contain all of the project and financial information a voter might wish to consider in casting a vote. Voters are urged to review the Full Ballot Text and the Tax Rate Statement to obtain a complete understanding of the measure, including all of the financial projections and estimates upon which the measure is based. The District Superintendent, or a designee thereof, is hereby authorized and directed to make any changes to the text of **Exhibit A**, as may be convenient or necessary to comply with the intent of this Resolution, the requirements of elections officials, or requirements of law.

Section 3. <u>Voter Pamphlet</u>. The County Registrar is hereby requested to print the Full Ballot Text (**Exhibit B** hereto), without Exhibit references, in the Voter Information pamphlet in its entirety. In the event the Full Ballot Text is not reprinted in the voter information pamphlet in its entirety, the County Registrar is hereby requested to print, immediately below the impartial analysis of the bond proposition, in no less than 10-point boldface type, a legend substantially as follows:

"The above statement is an impartial analysis of Measure__. If you desire a copy of the measure, please call the Solano County Registrar of Voters at and a copy will be mailed at no cost to you."

Section 4. Accountability Measures. Pursuant to legal requirements, and as specified in the Full Ballot Text, the Board certifies that the District:

- (a) Has evaluated the facilities needs of the District and has evaluated safety, class size reduction and information technology needs in developing the Bond Project List contained in the Full Ballot Text;
- (b) Will establish an independent Citizens' Bond Oversight Committee to ensure that bond proceeds are expended only for the school facilities projects described in the Bond Project List, in accordance with Education Code section 15278 et seq.;
- (c) Will conduct or cause to be conducted an annual, independent performance audit to ensure that the bond proceeds have been expended only on the school facilities projects described in the Bond Project List;
- (d) Will conduct or cause to be conducted an annual independent financial audit of the bond proceeds until all of those proceeds have been spent for the school facilities projects described in the Bond Project List; and
- (e) Shall take all actions to establish an account in which proceeds of the sale of the bonds will be deposited, and to cause a report to be filed with the Board no later than each April 30 identifying proceeds received and expended in the past fiscal year and the

status of any project funded or to be funded with bond proceeds. The first report shall be due no later than April 30 of the first year after which bonds have been issued and proceeds spent.

- Section 5. Required Vote. Pursuant to Section 18 of Article XVI and Section 1 of Article XIII A of the State Constitution, the above proposition shall become effective upon the affirmative vote of at least fifty-five percent (55%) of those voters voting on the proposition.
- Section 6. Request to County Officers to Conduct Election; Cost of Election. The County Registrar is hereby requested, pursuant to section 5322 of the California Education Code, to take all steps to call and hold the election in accordance with law and these specifications. The District will reimburse the Registrar and the County for costs associated with the election as required by law.

Section 7. Consolidation of Election and Canvass of Vote.

- (a) Pursuant to Section 15266(a) of the Education Code, the election shall be consolidated with the election on November 8, 2022.
- (b) The Board of Supervisors of Solano County is authorized and requested to canvass the returns of the election, as necessary, pursuant to Section 10411 of the California Elections Code.
- Section 8. Delivery of Order of Election to County Officers. The Clerk of the Board is hereby directed to deliver or cause to be delivered, no later than August 12, 2022, one copy of this Resolution to the County Registrar with the completed Tax Rate Statement (in substantially the form attached hereto as **Exhibit C**), completed and signed by the Superintendent or his designee, and shall file a copy of this Resolution with the Clerk of the Board of Supervisors of Solano County.
- Section 9. <u>Ballot Arguments</u>. The members of the Board are hereby authorized to prepare and file with the County Registrar a ballot argument in favor of the proposition contained in Section 1 hereof, and a rebuttal, if necessary, to any arguments against the measure, within the time established by the County Registrar.
- Section 10. Intention to Reimburse. The District may incur costs associated with bond-funded projects described in **Exhibit B** hereto prior to the issuance of bonds. For purposes of establishing compliance with the requirements of Section 1.150-2 of the regulations of the U.S. Treasury Department, the Board hereby declares its official intent to use proceeds of the bond to reimburse itself for lawful expenditures on capital projects described on the Bond Project List, up to a maximum principal amount of \$21 million.
- Section 11. Further Authorization. The Superintendent and Chief Business Officer (each, a "District Representative") are hereby authorized and directed, individually and collectively, to do any and all things that they deem necessary or advisable in order to effectuate the purposes of this Resolution, including selection of a final Ballot Label and modification of the Full Ballot Text, the Ballot Label, and Tax Rate Statement if he or she determines such modifications are necessary and in the District's best interests. This Resolution and all of its Exhibits that are filed with the County Registrar by a District Representative shall constitute the final, binding ballot measure of the District.

Section 12. Effective Date. This Resolution shall take effect upon its adoption.

By approval of this measure by at least fifty-five percent (55%) of the registered voters voting thereon, the Travis Unified School District shall be authorized to issue and sell bonds of up to \$64 million in aggregate principal amount to provide financing for the specific high school facilities projects listed below in the Bond Project List, subject to all of the accountability safeguards specified herein.

SECTION I: KEY FINDINGS

- The Governing Board of the District believes that a high quality education is the fundamental right of every student, and seeks to provide a 21st century education in a safe and engaging learning environment for all students;
- Many schools and buildings are over 50 years old, and many of schools need repairs and improvements to meet modern educational standards;
- The District must repair, construct, acquire or equip classrooms, sites, and facilities to make them safe and help ensure that all students have equal access to 21st century classrooms, labs and school facilities;
- Classrooms and educational facilities require updates for improved student learning in subjects like reading and science, technology, engineering, arts and math to accommodate 21st century learning methods and support hand-on instruction and learning by doing;
- The Board believes it is a wise investment to protect the quality of our schools, the quality of life in our community and the value of our homes:
- The District has reviewed its facilities needs and aligned them to the District's educational goals;
- Because State funding is limited, passing this bond measure provides a guaranteed source of local funding to maintain and improve this community's local school facilities;
- This bond measure will benefit local schools, and its funding will be controlled locally; no funds may be taken away by the State or other school districts, and by law, no money may be used for administrator salaries or pensions;
- This bond measure requires strict fiscal accountability protections including mandatory annual audits and an independent citizens' oversight committee to ensure funds are managed and spent properly.

SECTION II: ACCOUNTABILITY MEASURES

The provisions in this section are included in this proposition in order that the voters and taxpayers of the District may be assured that their money will be spent to address specific facilities needs of the District, all in compliance with the requirements of Article XIII A, section 1(b)(3) of the State Constitution, and the Strict Accountability in Local School Construction Bonds Act of 2000 (codified at Section 15264 et seq. of the California Education Code).

Evaluation of Needs. The Governing Board has evaluated the facilities needs of the District, and has identified projects to finance from a local bond measure at this time. The Governing Board hereby certifies that it has evaluated safety, class size reduction and information technology needs in developing the Bond Project List.

Independent Citizens' Oversight Committee. The Governing Board shall establish an independent Citizens' Oversight Committee to ensure bond proceeds are expended only for the school facilities projects listed in the Bond Project List. The committee shall be established within sixty (60) days of the date when the Board enters the results of the election in its official minutes.

Annual Performance Audit. The Board shall conduct or cause to be conducted an annual, independent performance audit to ensure that the bond proceeds have been expended only on the school facilities projects described in the Bond Project List.

Annual Financial Audit. The Board shall conduct or cause to be conducted an annual, independent financial audit of the bond proceeds until all of those proceeds have been spent for the school facilities projects described in the Bond Project List.

Annual Report to Board. Upon approval of this measure and the sale of any bonds approved, the Board shall take actions necessary to establish an account in which proceeds of the sale of bonds will be deposited. As long as any proceeds of the bonds remain unexpended, the Superintendent shall cause a report to be filed with the Board no later than April 30 of each year, commencing on the first April 30 after bonds have been issued and proceeds spent, stating (1) the amount of bond proceeds received and expended in the past fiscal year, and (2) the status of any project funded or to be funded from bond proceeds. The report may be incorporated into the annual budget, annual financial report, or other appropriate routine report to the Board.

SECTION III: BOND PROJECT LIST

This Bond Project List, which is an integral part of this measure, describes the projects the District proposes to finance with proceeds of the bonds. All information contained within this "Section III: Bond Project List" (hereinafter "Bond Project List") comprises the list and description of permissible projects and expenses that may be paid from bond proceeds, and where such projects may be or are intended to be completed.

Proceeds from the sale of bonds authorized by this measure shall be used only for the construction, reconstruction, rehabilitation, or replacement of school facilities listed in the Bond Project List, including the furnishing and equipping of said school facilities, or the acquisition or lease of real property for said school facilities, and not for any other purpose, including teacher or administrator salaries and other school operating expenses.

In order to meet all identified facility needs, the District may complete projects using a combination of funding sources, including development impact fees, mitigation fees, use funding, and state funding when and if available. The District will pursue state matching funds if and when they become available, and if received, they will be used for projects on the Bond Project List or other high priority capital outlay expenditures as permitted in Education Code section 17070.63(c).

While the District has budgeted to complete specific projects, due to potential cost escalation, unforeseen conditions, and other factors, placement of a project, or component thereof, on the Bond Project List is not a guarantee that each project or project component listed will be completed or that it will be completed at every location. While no project is dependent on the receipt of state funding, state funding may enable the District to perform additional projects or projects at additional sites, and bond funds may be used to meet any matching share contribution requirements.

Specific projects to be funded by the bond measure include, without limitation, the following:

A. PROJECTS TO PROVIDE UPGRADED SPACE FOR INSTRUCTION AND TO SUPPORT 21ST-CENTURY LEARNING

- Replace outdated and deteriorating utility infrastructure, electrical, lighting, plumbing, heating, sewer and ventilation systems;
 Install air conditioning or other classroom cooling systems;
- Upgrade/improve energy efficiency and install or replace energy conservation or generation systems (lighting, electrical, solar, geothermal) to reduce utility costs and to improve energy efficiency and implement sustainability and best/green energy practices;
- Improve security at schools by providing wayfinding, signage, fire and classroom intrusion alarms, public address and emergency
 communication systems, video surveillance cameras and other security systems, safety locks on classroom doors, and exterior
 lighting for student safety;
- Repaint school exteriors and interiors and refresh or replace landscaping;
- Replace doors and windows;
- Update and/or renovate classrooms by repairing and/or replacing flooring, ceiling tiles and casework, and re-painting and updating electrical systems;
- Install new or replace deteriorating campus fencing and gates;
- Improve student safety and traffic circulation by upgrading or providing additional school drop-off areas, safe paths of travel and parking lots;
- Improve site accessibility and install ramps to meet Americans with Disabilities Act (ADA) compliance;
- Repair and replace aging student and staff restrooms, including gender neutral toilet modernization, reconfiguration, and additions;
- Install or repair shade structures on school campuses and create sheltered eating and outdoor learning areas as needed.

Pay down capital leases or other lease-based debt obligations incurred for capital projects

B. PROJECTS TO ENABLE SCHOOLS TO MEET CURRENT ACADEMIC STANDARDS

- Construct, furnish and equip and/or renovate, modernize, upgrade, repair, replace:
 - Classrooms, science labs, career technical education spaces, and buildings;
 - Visual and performing arts theaters, spaces and venues, including multipurpose rooms;
 - Athletic fields, gyms, pools, hardcourts, physical education facilities, locker rooms and accessory facilities;
 - Food service facilities, community centers, meeting spaces, custodial spaces, workrooms, administrative offices and parent/ student support service areas;
- Improve school site network infrastructure and provide updated classroom audio/visual technology;
- · Acquire and install centrally manageable, networked loudspeaker/bell/clock systems;
- Furnish classrooms, learning and support spaces with furniture, screens, bulletin boards, and window coverings.

Projects listed above may be completed at any and all school sites and facilities where such project is determined by the Governing Board to be necessary or required, including administrative support facilities, and projects are authorized to be performed at any and all of the following locations:

Cambridge Elementary Center Elementary

Foxboro Elementary Scandia Elementary

Travis Elementary Golden West Middle School

Travis Community Day School Travis Education Center

Vanden High School

Listed projects, repairs, improvements, rehabilitation projects and upgrades will be completed as needed and feasible. Projects may be done in phases over time, based on Governing Board priorities and available funding. Decisions regarding the scope, timing, prioritization or other facets of project implementation will be made solely by the Governing Board by subsequent action. Where terms such as "repair," "upgrade," "replace" and "improve" are used in the Bond Project List, the Governing Board has the discretion to determine the best method for accomplishing the project's objective. For any listed project involving renovation or modernization of a building or the major portion of a building, the District may proceed with new replacement construction instead (including any necessary demolition), if the District determines that replacement and new construction is more practical than renovation, considering the building's age, condition, expected remaining life, comparative cost and other relevant factors. In addition, where feasible, projects may be completed in partnership with other public or private agencies on a joint use basis using bond proceeds, subject to federal tax rules and regulations. Property, buildings and equipment on the bond project list may be acquired through lease, sale, lease-purchase, lease-leaseback or other project delivery or acquisition methods determined appropriate by the Board. Bond funds may be used to support local match contribution requirements of state facility funding that becomes available for projects on the Bond Project List.

Each project is assumed to include its share of costs of bond issuance, architectural, engineering, legal and similar planning costs; construction management; bond project staff and consultants; staff development and training expenses associated with learning construction techniques and approaches and new bond-funded equipment and systems; the furnishing and equipping of all projects, including equipment to maintain facilities in a safe and clean condition; and a customary contingency for unforeseen design and construction costs. Payment of the costs of preparation of facilities planning and project implementation studies, feasibility and assessment reviews, master planning, environmental studies, permit and inspection fees, Division of State Architect (DSA) - related requirements, studies and assessments, including ADA and seismic, and temporary housing and relocation costs for dislocated programs or activities caused or necessitated by projects on the Bond Project List are permissible bond expenditures.

The final cost of each project will be determined as plans are finalized and projects are completed. Based on the final costs of each project, certain of the projects described above may be delayed or may not be completed. Necessary site preparation, grading or restoration may occur in connection with acquisition of property, new construction, modernization, renovation or remodeling, or installation or removal of modular classrooms, including ingress and egress, removing, replacing or installing irrigation, utility lines, trees and landscaping, relocating fire access roads and acquiring any necessary easements, leases, licenses or rights of way to the property, all of which are permitted expenses.

SECTION IV: ADDITIONAL SPECIFICATIONS

No Administrator Salaries. Proceeds from the sale of Bonds authorized by this proposition shall be used only for the construction, reconstruction, rehabilitation or replacement of school facilities on the Bond Project List, including the furnishing and equipping of said school facilities, or the acquisition or lease of real property for said school facilities, and not for any other purpose, including teacher and administrator salaries and other school operating expenses as interpreted by applicable law.

Single Purpose. All of the purposes enumerated in this proposition shall be united and voted upon as one single proposition, pursuant to Section 15100 of the California Education Code, and all the enumerated purposes shall constitute the specific single purpose of the bonds and proceeds of the bonds shall be spent only for such purpose.

No Long Term Debt for Short Lifespan Items. The weighted average maturity of each issue of bonds will not exceed 120 percent (120%) of the average reasonably expected economic life of the projects financed by the bonds, consistent with federal tax law.

Other Terms of the Bonds. The bonds may be issued and sold in several series, and in accordance with a financing plan determined by the Governing Board pursuant to requirements of law. When sold, the bonds shall bear interest at an annual rate not exceeding the statutory maximum and with a maximum term not exceeding the statutory maximum, provided that Bond funds may be used to reimburse the District for Bond Project list expenditures incurred prior to the election and bond issuance, in accordance with federal tax law.

Attention of all voters is directed to the fact that the financial information contained in this measure is based upon the District's projections and estimates only, which are not binding upon the District, nor are the summary estimates, if any, provided in the Ballot Label. The actual tax rates, debt service and the years in which they will apply may vary from those presently estimated, due to variations from these estimates in the timing of bond sales, the amount of bonds sold and market interest rates at the time of each sale, and actual assessed valuations over the term of repayment of the bonds. The dates of sale and the amount of bonds sold at any given time will be determined by the District based on need for construction funds and other factors. The actual interest rates at which the bonds will be sold will depend on the bond market at the time of each sale. Actual future assessed valuation will depend upon the amount and value of taxable property within the District as determined by the County Assessor in the annual assessment and the equalization process.

In preparing this information, the District obtained reasonable and informed projections of assessed property valuations that took into consideration projections of assessed property valuations made by the County Assessor, if any, in accordance with Education Code Section 15100(c).

EXHIBIT C

TAX RATE STATEMENT

An election will be held within the boundaries of the Travis Unified School District ("District") on November 8, 2022 to authorize the sale of up to \$64,000,000 in bonds to finance facilities as described in the measure. If the bonds are approved, the District expects to sell the bonds in multiple series. Principal and interest on the bonds will be payable from the proceeds of tax levies made upon the taxable property located within the District. The following information is provided in compliance with Sections 9400 to 9404, inclusive, of the California Elections Code.

- 1. The best estimate from official sources of the average annual tax rate that would be required to be levied to fund this bond issue over the entire duration of the bond debt service, based on assessed valuations available at the time of the election or a projection based on experience within the same jurisdiction or other demonstrable factors, is estimated to be approximately \$0.06 per \$100 (\$60 per \$100,000). The final fiscal year in which the tax is anticipated to be collected is fiscal year 2051-52.
- 2. The best estimate from official sources of the highest tax rate that would be required to be levied to fund this bond issue, based on assessed valuations available at the time of filing this statement or a projection based on experience within the same jurisdiction or other demonstrable factors, is estimated to be approximately \$0.06 per \$100 (\$60 per \$100,000) of assessed valuation, which is projected to be the same in every fiscal year that the bonds remain outstanding.
- 3. The best estimate from official sources of the total debt service, including the principal and interest, that would be required to be repaid if all the bonds are issued and sold will be approximately \$124 million, considering the assumptions set forth in paragraphs (1) and (2) above. This estimate results in a debt service ratio of 1.9 to 1, which is less than the maximum ratio of 4.0 to 1 allowed by Education Code Section 15144.1.

If the bonds are approved, the duration of the tax levy shall continue until final payment of all bonds issued pursuant to the authorization. The tax shall be levied in an amount each year sufficient to pay the principal of and interest on all outstanding bonds issued pursuant to the authorization. Voters should note that the estimated tax rate is based on the ASSESSED VALUE of taxable property on the Solano County official tax rolls, not on the property's market value. Property owners should consult their own property tax bills to determine their property's assessed value and any applicable tax exemptions.

Attention of all voters is directed to the fact that while the foregoing information includes conservative projections and estimates of assessed value, market interest rates, and the timing and amount of bonds issued in the future, the District will only issue bonds if the tax rate is at or below the maximum set forth above. The County Assessor is responsible for determining assessed value, the County Auditor-Controller is responsible for setting tax rates, and the County Treasurer-Tax Collector is responsible for the collection of taxes. The actual tax rates may vary over time based on changes in assessed value, and actual debt service may vary based on market interest rates and the timing of when the bonds are issued. The dates of sale and the amount of bonds sold at any given time will be determined by the District based on need for construction funds and other factors. The actual interest rates at which the bonds will be sold will depend on bond market conditions at the time of each sale. Actual future assessed valuation will depend upon the amount and value of taxable property within the District as determined by the County Assessor in the annual assessment and the equalization process. The District is responsible for the timing and amount of bonds to be issued, which the District will only undertake if tax rates meet the parameters set forth in the above tax rate statement.



VOTER BILL of RIGHTS



YOU HAVE THE FOLLOWING RIGHTS



- The right to vote if you are a registered voter. You are eligible to vote if you are:
 - ★ a U.S. citizen living in California
 - * at least 18 years old
 - registered where you currently live
- ★ Not currently serving a state or federal prison term for the conviction of a felony, and
- not currently found mentally incompetent to vote by a court
- 2. The right to vote if you are a registered voter even if your name is not on the list.

You will vote using a provisional ballot. Your vote will be counted if elections officials determine that you are eligible to vote.

- 3. The right to vote if you are still in line when the polls close.
- 4. **The right to cast a secret ballot** without anyone bothering you or telling you how to vote.
- 5. **The right to get a new ballot if you have made a mistake,** if you have not already cast your ballot. You can:
 - **Ask an elections official at a polling place** for a new ballot, **Exchange your vote-by-mail ballot** for a new one at an elections office, or at your polling place, or
 - Vote using a provisional ballot.
- 6. **The right to get help casting your ballot** from anyone you choose, except from your employer or union representative.
- 7. The right to drop off your completed vote-by-mail ballot at any polling place in California.
- 8. **The right to get election materials in a language other than English** if enough people in your voting precinct speak that language.
- 9. The right to ask questions to elections officials about election procedures and watch the election process. If the person you ask cannot answer your questions, they must send you to the right person for an answer. If you are disruptive, they can stop answering you.
- 10. **The right to report any illegal or fraudulent election activity** to an elections official or the Secretary of State's office.

SPECIAL NOTICE

- Polls are open from 7:00 a.m. to 8:00 p.m. on the day indicated in the posted county Voter Information Guide.
- Specific instructions on how to vote, including how to cast a provisional ballot, can be obtained from a poll worker or by reading the information mailed to you by your local elections official.
- If you are a newly registered voter, you may be asked to provide appropriate identification or other documentation according to federal law. But please note that every individual has the right to cast a provisional ballot even if he or she does not provide the documentation.
- It is against the law to represent yourself as being eligible to vote unless you meet all of the requirements to vote under federal and state law.
- It is against the law to tamper with voting equipment.
