**RESOLUTION NO. 2024-02-23**

**Approving Subventions Application and CEQA Exemption for Annual Levee Maintenance**

WHEREAS, Reclamation District 1667 (the "District") operates and maintains several miles of existing levee and drainage systems on Prospect Island; and

WHEREAS, operation and maintenance of existing facilities is generally exempt from the California Environmental Quality Act; and,

WHEREAS, the District desires to apply to the Delta Levee Subventions Program for funds to complete routine maintenance.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Trustees of Reclamation District 1667 as follows:

1. The work described in the Fiscal Years 2024-2025 Delta Levee Subventions Program Applications consists of routine maintenance to existing levee improvements and falls within the categorical exemptions to the California Environmental Quality Act pursuant to Section 15261 and 15301 (Class I) of the Guidelines for the California Environmental Quality Act, California Administrative Code of Regulations, Title 14, Chapter 3, Article 19. The Board finds and determines the work contemplated under the agreement constitutes "maintenance" and is therefore not a "covered action."
2. The District finds the proposed work will not have a material adverse effect upon the environment.
3. The work does not constitute an exception to the exemptions of the California Environmental Quality Act.
4. The District Engineer is hereby directed to apply to the Delta Levee Subventions Program as well as prepare and file with the County Clerk of Solano County and the SCH for posting, a "Notice of Exemption" pursuant to California Administrative Code, Title 14, Chapter 3, section 15062.
