Vacaville Unified School District

Our schools are some of the most important assets in our community and should be our number one priority. From higher achieving students to greater neighborhood safety and improved property values, quality schools make a difference. Although teachers and staff do their best in educating our children, many classrooms and school facilities at the Vacaville Unified School District are outdated and inadequate to provide students with the proper school facilities they need to succeed. This is why our children need your **YES vote on Measure E!**

Although our schools have been well maintained over the years, many classrooms are old and don't meet today's safety, technological, and educational standards. The average age of our schools is over 45 years old, with Vacaville High, our oldest, being constructed over 70 years ago. In addition, due to residential growth in Vacaville, our campuses are becoming overcrowded. We need major classroom and infrastructure improvements to maintain the quality of education provided to children.

If passed, Measure E will improve education locally by:

- Repairing or replacing leaky roofs
- Making safety and security improvements
- Providing additional science, technology, engineering, and mathematics (STEM) labs and classrooms
- Constructing a new school to relieve student overcrowding throughout the district


