#### 2 PC 24-023

Conduct a noticed public hearing to consider Use Permit U-23-04 by Vertical Bridge to construct and operate a new wireless communications facility consisting of a 95-foot tall monopole within a 40 x 40 sq. ft. lease area located at 4448 Holland Road, 7 miles northeast of the City of Rio Vista, within the Exclusive Agriculture "A-80" zoning district, APN 0042-200-330. The project is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15303, New Construction or Conversion of Small Structures.

Senior Planner Eric Wilberg presented use permit application U-23-04 to the Commission. Mr. Wilberg noted that the applicant additionally proposed two stealth mount (windmill and eucalyptus) alternatives for consideration by the Commission.

Chairperson Bauer asked if there was a need for stealth mount. Mr. Wilberg indicated it was for consideration of the Commission but not a requirement.

Commissioner De La Rosa stated he was in favor of stealth mount, citing aesthetic concerns. He also suggested clarification regarding the allowance of the additional 20-feet height prior to colocation in Zoning Code Section 28.81(D)(5)(c); and recommended a certified mailer requirement during the applicant's alternative site analysis.

Resource Management Director James Bezek stated a potential cost burden to the public if a certified mail requirement was mandated. Staff will review whether a certified mail requirement can be implemented at the recommendation of the Commission or if a zone text amendment would be required.

Deputy County Counsel Holly Tokar acknowledged the clarification request from Commissioner De La Rosa to Section 28.81(D)(5)(c) and will consider a zone text amendment to bring to the Commission.

The applicant, Nicholas Votaw, representing Vertical Bridge, clarified that collocation on an existing structure was not feasible due to the distance to the nearest suitable tower. He also stated a preference for the proposed green monopole, citing cost-effectiveness and environmental considerations.

Chairperson Bauer opened the public hearing. There was no public comment.

Chairperson Bauer closed the public hearing.

Commissioner Cayler motioned to adopt the resolution as proposed, seconded by Commissioner Gaddies.

Commissioner De La Rosa alternatively motioned to adopt the resolution with the stealth mount requirement, seconded by Chairperson Bauer. The motion did not pass by 1-3 vote.

On motion of Commissioner Cayler, seconded by Commissioner Gaddies, the Commission adopted the resolution as proposed to approve item PC 24-023, Use Permit application U-23-04 of Vertical Bridge. So ordered by a 4-0 vote.
