The project will install a new modular TK classroom with two student restrooms within the grounds of Orchard Elementary School, along with connections to existing storm drainage, sewer, and water service systems, and ADA path of travel paving improvements. Additionally, the project will include accessibility upgrades to an existing staff restroom and ADA parking, installation of low voltage systems, and the provision of building identification and exit signage.
