- b. CCP (Community Corrections Partnership) – Andrew Williamson, Solano County, Substance Abuse (SA) Administrator
  - January meeting was cancelled; no report
- c. Substance Abuse Administrator’s Report – Andrew Williamson, Solano County, SA Administrator
  - SA is currently receiving a lot of new contracts because Counties are now required by the State to pay for the residents’ treatment no matter where their treatment was received (mostly methadone programs)
  - Solano County is now surrounded by waiver counties which makes it more difficult for SA to get residential beds due to the low rate of \$100/day that we pay providers vs \$240/day; Andy visited a new residential facility for men in Clearlake Oaks and have started the process for their new contract
  - SA will soon start a master agreement with Thunder Road in Oakland for adolescent residential treatment which will cost \$10k/mo. for treatment

- Dr. Wu from the Fairfield Family Health Clinic will be providing Medication-Assisted Treatment (MAT) starting tomorrow and Dr. Kinnevey who works for Medmark and Touro University will be providing MAT at the Vallejo Family Health Clinic
- Solano County has been working on integrating Mental Health and Substance Abuse; MH will take over the SA Access Line and will use a DHCS phone screening tool that was created by UCLA if all goes well
- Partnership HealthPlan of CA will be meeting with DHCS soon to review their new fiscal plan for the ODS Waiver and then a readiness review after that; people do not think the waiver will start on July 1, 2018
