 - Next meeting in late April
 - Quarter 3 data report from SA shows there has not been much activity with AB109 clients
- c. Substance Abuse Administrator’s Report – Andrew Williamson, Solano County, SA Administrator
 - SA has been busy and on a deadline with correcting data entry errors made by the new methadone contractor for the DMC claiming
 - Prop 47 convention “State of Reentry” scheduled for April 24th 8:30-1:00 with keynote speaker, Kim Carter; this event is required by the grant. Currently, there are 117 Prop 47 clients since July 1st and 19 approved SLE housings all being coordinated by Patty Ayala. SA will be meeting with a potential contractor to take over the organization of the faith-based network
 - Partnership is supposed to give the County the total cost for April as well as the contract between DHCS and the County, and Partnership and the County; Partnership is also supposed to give out the provider contracts in April
 - All SA calls are being routed to the MH Access Line as part of the MH/SA Integration; Few SA staff will be working at the Call Center
 - Patrick Stasio from the Family Health Services will soon be training the SA Staff on Narcan and will provide the staff some boxes of the medication

 - An article on drug, alcohol, and suicide deaths was provided to everyone present; Wendy also provided the death rates in Solano County; Solano County is above the State total average
