# Bay Area Multifamily Building Enhancements Steps



## 1. Complete & Submit Interest Form

Fill in a paper interest form or go online to [Multifamily.EnergyUpgradeCA.Org](http://Multifamily.EnergyUpgradeCA.Org) to complete an online interest form. The program staff will contact you about your potential eligibility within 3 business days and if applicable will set up an initial consultation with the free energy consulting providers.

## 2. Get Free Energy Consulting

During an initial consultation, you and your advisor will shape the type of consulting that will help you meet your upgrade goals. The free services can include: Program referral, utility bill analysis, advice on improvements to consider, prioritization and cost effectiveness advice. The energy consulting providers will utilize energy simulation software to define a package of enhancements to achieve 10% or more energy savings and qualify for the cash rebate. The services also include a free site visit to confirm the existing conditions and appropriateness of the improvements.

## 3. Reserve Your Rebate

Once the site visits are completed, and your enhancements have been approved, you may reserve your rebate by creating an online account. You will reserve a total amount that is equal to \$750 x the number of units in your building. For example:

Number of Units	Rebate Amount
5	\$3,750
20	\$15,000
50	\$37,500
100	\$75,000

You will receive notification confirming that your rebate is reserved.

## 4. Install Property Enhancements Using Your Own Contractors

When installing property enhancements you may hire any contractor that is properly licensed and abiding by all applicable laws. Keep the energy consulting providers updated on your installation timeline and progress. At certain key points, they will coordinate with you to arrange the free on-site verification of installed equipment

## 5. Claim Your Rebate

Once you have completed construction and the site visits, you can log onto your account and submit a rebate claim. Approved claims are processed within 90 days and you will receive a check.
